The remaining cars will run the qualifying race, transferring the top five (5) finishers to the A-Main (starting in positions 21 - 25), Positions 26 set by (1) SPL driver's provisional for the highest-ranking in the top 20 in 2024 championship standings whose car did not qualify for the A-Main can use a provisional. Those competitors running in the qualifying race that transfer to the A-Main Event will be allowed to buy or change to approved tires for the Feature event. Qualifying race will be run straight up.
